

I, as per the details I have entered in the above form, hereby apply for a position as an official at the 2019 Formula 1® Australian Grand Prix (the "Event") which is scheduled to take place from 14 March to 17 March, 2019 Dates to be confirmed.

I volunteer my services and am willing to act as an official to the 2019 Formula 1® Australian Grand Prix, and will be available for the four days of the Event. In so applying and in consideration of my application being accepted I:

- Agree to release Confederation of Australian Motor Sport Ltd ("CAMS"), Australian Motor Sport Commission Ltd, CAMS State Councils and Clubs, the Australian Grand Prix Corporation ("AGPC"), the Crown in right of the State of Victoria, the Minister administering the Australian Grand Prix Act 1994 (Vic), the Minister administering the Crown Land (Reserves) Act 1978 (Vic), Federation Internationale de l'Automobile, Formula One Administration Ltd, Formula One Management Ltd, Parks Victoria, Kellogg Brown & Root Pty Ltd, promoters, sponsor organisations, their respective servants, officials, employees, representatives and agents (collectively, the "Associated Entities") from all liability for my death, personal injury (including burns), psychological trauma, loss or damage (including property damage) ("harm") howsoever arising from my participation in or attendance at the Event, except to the extent prohibited by law;
- Acknowledge and agree that CAMS and the Associated Entities do not make any warranty, implied or express, that the event services will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied; and
- \square Acknowledge and agree that attendance at and participation in the Event is at my own risk;
- Agree to indemnify and keep indemnified the Associated Entities against any claim, loss, liability, damage, cost or expense which may be incurred by any or all of the Associated Entities as a result of any claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

I acknowledge that:

- ☐ The risks associated with attending or participating in the Event include the risk that I may suffer harm as a result of:
- Motor vehicles (or parts of them) colliding with other motor vehicles, persons or property;
- Acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the Event; and
- ☐ The failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure the safety of persons or property at the Event.
- $f \square$ Motor sport is dangerous and that accidents causing harm including death or serious injury can and do happen and may happen to me.

This release and indemnity is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.

WARNING UNDER THE FAIR TRADING ACT 1999

Under the provisions of the Fair Trading Act 1999 several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:

- f Q As fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- ☐ Reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004

For the purposes of the clause 3, "the Supplier" shall mean and include the Associated Entities.

I accept the conditions of, and acknowledge the risks arising from, attending or participating in the Event and being provided with the event services by CAMS and the Associated Entities.

In consideration of CAMS as the organisers accepting my application I:

- Acknowledge and agree that if I receive medical advice or treatment from a member of the Organisers medical team, including those staffing the medical centre, I consent to relevant clinical information being disclosed to the Chief Medical Officer or his delegate to ensure my ongoing care
- Hereby consent to the collection of my personal information by CAMS and AGPC in connection with my involvement at the Event and acknowledge and agree that information, including personal details held by CAMS and AGPC may be distributed to agencies and other officials associated with the Organisation of the Event, whilst such information is for activities considered to be essential to the conduct and management of the Event. - ☐ Declare that I am medically and physically fit and free from impairment and able to carry out normal duties expected of the position for which I hereby apply at the Event
- Declare that I am familiar with the requirements and activities of a CAMS official
- $f \square$ Agree to participate in and fully complete, to the satisfaction of CAMS, all training programs conducted by CAMS and associated with my involvement with the Event
- $f \square$ Am willing to submit myself to the controls and restrictions applied to all officials at the Event

A term of this disclaimer and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

I understand that this disclaimer is not intended to exclude any valid claim by an official under the CAMS Personal Accident Insurance Scheme.

Any official making a false declaration is liable to refusal and cancellation of licence and/or insurance cover
